#### NON-REGULAR CLASS ( involving Single Dog Entries )

**VETERAN** A class for dogs and a class for bitches seven years of age or older. The winners of these classes will be eligible to compete in the Best of Breed Competition.

## BEST OF BREED

#### NON-REGULAR CLASS (involving Multiple Dog Entries)

As the judge's decision in the following classes is based on the merits of more than one dog or bitch, no one of the dogs or bitches judged first in these classes will be eligible to compete for Best of Breed by virtue of having won in these classes.

**STUD DOG** For Stud Dogs and at least two, but not more than four of their Get. Owner of the Stud Dog need not necessarily be the owner of the Get. Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with its' Get. Get will only be judged on the basis of their merits. Each dog entered as a Get must be entered in a regular class, Best of Breed Competition, or some Non-Regular Class other than Stud Dog. NOTE: There is no additional fee to the Get for the Stud Dog Class.

**BROOD BITCH** Same as for Stud Dog Class, substituting Brood Bitch for Stud Dog and Produce for Get.

## CHALLENGE TROPHY

#### BEST OF BREED

A wood plaque offered by the Dallas Miniature Pinscher Club for competition at the DMPC Specialties. For permanent possession, the trophy must be won three times by the same owner, not necessarily the same dog, nor at consecutive specialties. After the show, the present trophy chairman shall be responsible for getting the trophy to the next trophy chairman who shall keep the trophy in his/her possession until the next show or the requirements for winning are met.

Hotel staff will continuously monitor all rooms for dog-related problems and damage to any room by either dog or exhibitor which will result in an event committee hearing.

A Recording Fee of \$.50 and an AKC Event Service Fee of \$3.00 will be required for each dog entered at any Licensed or Member Club Show or Obedience Trial.

This Recording Fee is to be collected by the show giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the Recording Fee is to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2)

**Canadian exhibitors must submit entries with checks drawn on U. S. accounts or with international money orders in U. S. funds.**

There will be no refund for duplicate entries.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs allowed in rings during judging only.

Dogs must be ready for judging. Neither the club nor its Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

The Club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show — None will be mailed.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

**Returned checks do not constitute a valid entry fee.** The club will add a collection fee equal to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH only basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judge or barred from competition by action of the Show Committee.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Show Secretary.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form.

Changes, additions or corrections to entry forms must be received in writing or by telegram prior to close of entries. Those received by telephone are not acceptable.

An administrative fee of \$5.00 may be charged for all cancellations or changes made prior to closing of entries.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

1. (Variety) If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e. Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rules refer to Chapter 11, Section 3.)
